



This Contract (as defined below) sets out the Conditions under which we will provide the Service (as defined below) to you.

By “you” or “your” we mean the “Customer” as defined below.

By “us” and “we” we mean With A Legend Limited, trading as “Bake With A Legend” a company registered in England and Wales under Company number 10374892 and having its registered office at 7 Holders Hill Drive, London, NW4 1NL (“With A Legend”, “Bake With A Legend” or “BWAL”).

### **Meaning of Terms**

In this Contract (unless the Contract otherwise requires), the following words shall have the following meanings:

**Booking** means the request and Confirmation of the Service (in the form of a Receipt).

**Customer** means any person making a Booking (whether they are a Participant or not).

**Conditions** means these terms and conditions, as amended from time to time by BWAL.

**Confirmation** means the email sent by BWAL setting out the exact details of the Event, including but not limited to the Date, Venue, Legends and Price agreed with the Customer.

**Contract** means these Conditions, the Confirmation and any other agreement between the Customer and BWAL arising out of the Booking.

**Date** means the date of the Event as specified in the Confirmation.

**Deposit** means the amount charged (20% of the Price) by BWAL due upon the Customer’s receipt of our invoice.

**Event** means the unique experience organised by BWAL for which the Booking has been made, the exact details of which are set out in the Confirmation.

**Full Payment** means the amount (the Price minus the Deposit) requested by BWAL under the terms of the Contract.

**Legend** means a former participant in Great British Bake Off who has agreed to take part in Events organised by BWAL.

**Participant** means any person taking part in the Event.

**Price** means the price specified in the Confirmation.

**Service** means the services as provided by BWAL as set out in the Contract.

## **Bookings and Fees**

1. A Booking is confirmed only when a Customer has:
  - a. Made an enquiry to BWAL, AND
  - b. Agreed the Price, Date and number of Participants with BWAL, AND
  - c. Been issued with a Confirmation and an invoice by BWAL, AND
  - d. Paid the invoice in full.
2. BWAL will issue the invoice for the entire Fee four weeks prior to the date of the Event.
3. The full Fee is due for payment two weeks prior to the date of the Event.
4. Should the Customer decide not to proceed with the Event once the Booking has been Confirmed and the invoice has been issued, BWAL reserves the right to charge the Customer the full Fee and to take any appropriate steps necessary to recover that Fee. In reality we will deal with these issues on a case-by-case basis and will work with the customer to arrange an alternative event where possible.
5. Should the Customer not make Full Payment upon request, BWAL reserves the right to cancel the event and take any appropriate steps necessary to recover the outstanding balance of the Fee. In reality we will deal with these issues on a case-by-case basis.
6. It is the Customer's responsibility to ensure that all Participants fulfil any obligation arising out of the Contract.

## **BWAL's Obligations**

7. BWAL will arrange the Event.
8. Specifically BWAL will provide the following in respect of the Event:
  - a. Hire of an appropriate kitchen to hold the Event;
  - b. A glass of Prosecco for all Participants;
  - c. The attendance of a Legend;
  - d. A kitchen cleaner;
  - e. All necessary equipment for the Event;
  - f. All necessary ingredients for the Event;
  - g. Aprons for use by all Participants during the Event;

- h. Snacks for all Participants throughout the Event
  - i. Speakers so that music can be played throughout the Event;
  - j. Boxes to allow Participants to take left-overs home with them;
  - k. Prizes to be awarded to the best baker from the Participants;
9. BWAL will organise Public Liability Insurance, the details of which are available upon request.
10. BWAL can also forward all relevant insurance documentation pertaining to any venue used for Events upon request.

### **The Event**

11. All Participants are required to sign a Disclaimer prior to the start of an Event.
12. Participants will bake in pairs throughout the event.
13. The full details of the Booking will be found on the Confirmation. However Bookings are normally for 3 hours and will start at either 10am or 2pm on a Saturday or a Sunday.
14. BWAL can accommodate a minimum of 12 and a maximum of 20 Participants at our Events.

### **The Legends**

15. The Legends listed on the BWAL website are Legends that have agreed with BWAL to be available for Events.
16. The Customer is free to request a specific Legend for their Event, however BWAL cannot guarantee the attendance of a specific Legend.
17. BWAL will endeavour to provide you with confirmation of which Legend will be attending the Event, as soon as is practicable after Booking is complete.
18. BWAL reserves the right to not agree to any Booking that is made on the basis of the guaranteed attendance of any specific Legend. In reality we will consider any requests in this regard on a case-by-case basis.
19. Should the Legend confirmed by BWAL pursuant to condition 17 above be unable to attend the Event for any reason, BWAL will facilitate the attendance of another Legend. As (pursuant to condition 16 above) BWAL cannot guarantee the attendance of any Legend at an Event, the replacement of the Legend does not allow the Customer to cancel their



Booking. BWAL is under no obligation to offer any refund in these circumstances.

20. All Legends provided by BWAL are reminded of their responsibilities in order to ensure everyone attending has an enjoyable experience
